

# TIME'S<sup>™</sup> LEGAL DEFENSE FUND UP

The TIME'S UP Legal Defense Fund, administered by the National Women's Law Center Fund, is a groundbreaking initiative that connects those who experience workplace sexual harassment and related retaliation with legal and media assistance. The Fund connects workers seeking assistance with its network of attorneys. The Fund helps defray the costs of selected legal cases especially for low-wage workers; women in male-dominated occupations; workers who are facing defamation suits; and workers who are fired or blacklisted after reporting harassment.

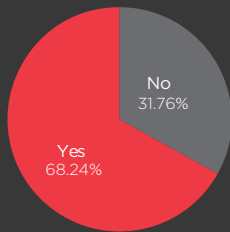

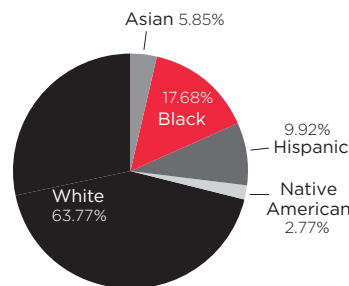

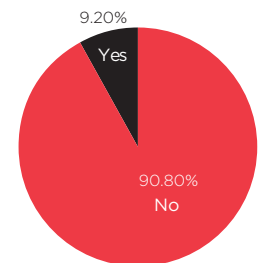
